In the event of any inconsistency between the terms hereof and the terms set forth in the Contract, the terms hereof control.

<u>NOTE:</u> The amount or rate of broker compensation (including shared compensation) is not set by law and is negotiable. Further, Cooperating Broker is prohibited from accepting any amount of compensation that is greater than what Buyer has agreed to pay under any brokerage agreement.
